This notice is being issued for Online Registration, Scanning & uploading of documents, Documents E- Verification, reporting to Institutes by candidates aspiring for admissions to First Year Full-time course in **M. Planning Programme** at COEP Technological University (COEP Tech), Pune for the Academic Year 2023-24.

**Process of application:** The Candidate shall register online on COEP Tech website ([www.coep.org.in](http://www.coep.org.in)), the candidate shall fill & submit online application form and upload the required documents from anywhere through the computer connected to internet and he/she need not have to visit personally for verification of the application form. His/her application & documents shall be verified and confirmed by the COEP Tech, E-Scrutiny Center through online mode only (refer activity schedule for details).

### **Important Instructions for candidates:**

1. All the rules and regulations of admission for the academic year 2023-24 will be in accordance and governed by ME/MTech/ M.Planning, MBA information brochure published on CET Cell of Government of Maharashtra (<https://cetcell.mahacet.org/>).
2. If candidates fail to submit and upload online filled application by E-Scrutiny center of CoEP, then such applications will be rejected and name of such candidates will not appear in the merit list(s) prepared for the purpose of Admission.
3. \*EWS candidates shall produce the Eligibility Certificate for Economically Weaker Section (Proforma-V).
4. Sponsored students should produce certificate of Employer (Proforma-P) as shown in information brochure of ME/MTech on <https://cetcell.mahacet.org/> under ME/MTech - Under rules and brochure for academic year 2023-24.
5. For Union Territory of Jammu and Kashmir and Union Territory of Ladakh Migrant and /NRI/PIO/OCI/CIWGC/FN Candidates: -Such Candidates will get the Receipt-cum-Acknowledgement through their login after confirmation of application by E-Scrutiny center of COEP Tech. Applications received after the last date from candidates will be summarily rejected and no correspondence will be entertained in this regard.
6. Candidates who have registered as a reserved category candidate but unable to produce required certificate for reservation claim during E-documents verification stage shall have to pay difference of fee of Rs. 200/- through online mode only and such candidates will be considered as OPEN category candidates.
7. A Candidate who has been allotted a seat shall confirm the seat by reporting at College of Engineering Pune. Non-Confirmation/ Non-reporting by candidates for the provisional allotment will be treated as cancellation of allotment to the particular seat and will be shown as vacant in subsequent allotment round.
8. The Seat Acceptance Fee shall be Rs.1,000/- for all Candidates. The candidate has to pay the Seat Acceptance Fee during first reporting only. This fee shall be treated as non-refundable processing fee. The Seat Acceptance fee is to be paid through His/ Her Own login by ONLINE MODE only.
9. As per the allotment, seat will be confirmed by COEP Tech after verification of the original documents and ensuring that the Candidate meets all the eligibility norms and the requisite fee by the COEP Tech. The admission in-charge of COEP Tech shall issue the Online Receipt of admission confirmation to the candidate.
10. **The SC, ST, VJ/DT- NT(A), NT(B), NT(C), NT(D), OBC, SBC and EWS Candidates who submitted receipt of Caste/Tribe Validity Certificate, Non Creamy Layer Certificate, EWS Certificate during registration, e-verification or physical document verification and confirmation period should upload and verify original Caste/ Tribe**

**Validity Certificate, Non Creamy Layer Certificate, EWS Certificate at Physical Scrutiny Center or E-Scrutiny Center and submit original certificate to the admitted institute on or before third round last date of reporting otherwise these candidates admission will get automatically cancelled and shall be considered as Open category candidates for next institute level round provided candidate full fill eligibility criteria for open category.**
